DOBERMANN BREED COUNCIL – CRITERIA FOR COMPLETION OF JUDGING LISTS

B LIST – BREED SPECIALIST

The applicant should send 3 copies of the questionnaire and 3 copies of certificates to the Secretary of the Club, when applying for proposal by the Club

(Persons who would be supported to judge the breed at Open Shows to comply with KC guidelines i.e. Band D)

1. To have been actively involved in the breed (to have owned solely or in partnership, bred, showed or handled) for not less than 5 years and have the support of the Breed Council.
2. To have judged a minimum of 30 classes of Dobermanns at open shows with a minimum of 100 dogs 'hands on' (excluding absentees).
3. To have judged the breed at a minimum of eight (8) Open Shows
4. To have stewarded at a minimum of six (6) Shows (Open or Championship).
5. To have attended at least one Dobermann Breed Specific Judging Seminar – plus one of the following:-
 - a) To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on Kennel Club Regulations and Judging Procedures.
 - b) To have attended a Conformation and Movement 'Hands On' Assessment conducted by a Kennel Club Accredited trainer and passed the assessment (KC Policy as of 01.07.2005).

IMPORTANT NOTES FOR APPLICANTS

ALL applicants for consideration to all judging lists are at the discretion of the member Club's of the Breed Council.

Any application form listing shows from 1990 onwards. ALL records must be complete, otherwise, the show will not be included.

Any application with shows prior to 1990, records which are incomplete, a 25% reduction will be made on the entry detail.
