DOBERMANN BREED COUNCIL – CRITERIA FOR COMPLETION OF JUDGING LISTS

The applicant should send 9 copies of the questionnaire and 3 copies of certificates to the Secretary of the Club, when applying for proposal by the Club.

A3 NON BREED SPECIALIST

1. Minimum of seven (7) years judging experience in any one breed (to include 5 years in this breed) and have the support of the Dobermann Breed Council.
2. To have judged a minimum of fifty (50) Dobermann Breed classes at Open or Championship Shows plus at least one Dobermann Breed Club Open show. Breed Club Shows must be 150 miles apart.
3. To have judged Dobermanns at a minimum of ten (10) breed Open or Championship Show.
4. To have judged a minimum of at least 250 Dobermanns (dogs in attendance).
5. To be included on a Dobermann Breed Council 'B' Judging List.
6. To be KC approved to award Challenge Certificates in 1 breed or more within the Pastoral/Working Group .
7. To have attended at least one Dobermann Breed Specific Judging Seminar run in accordance with the relevant Kennel Club Code of Best Practice.
8. To have attended, completed and passed a judges assessment day/test, held specifically for Dobermann's. Organised by one of the DBC member Clubs and run to the agreed format
9. To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on Kennel Club Regulations and Judging Procedures. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*
10. To have attended a seminar given by a Kennel Club Accredited Trainer on conformation and Movement and passed the relevant examination. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*
- 10a To have attended a Conformation and Movement 'Hands On' Assessment conducted by a Kennel Club Accredited trainer and passed the assessment. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*
11. To have bred and/or owned a minimum of 3 dogs when they obtained their first entry in The Kennel Club Stud Book (save in exceptional circumstances – please give written explanation)

IMPORTANT NOTES FOR APPLICANTS

ALL applicants for consideration to all judging lists are at the discretion of the member Club's of the Breed Council.

Any application form listing shows from 1990 onwards. ALL records must be complete, otherwise, the show will not be included.

Any application with shows prior to 1990, records which are incomplete, a 25% reduction will be made on the entry detail.
