3. To have attended a seminar on KC Rules and Regulations given by a KC accredited Trainer and passed a test. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*
4. To have attended a seminar on Conformation and Movement given by a KC accredited Trainer. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*
5. To have stewarding experience. *(Except where the applicant is already approved by the Kennel Club to award Challenge Certificates in another breed)*

**IMPORTANT NOTES FOR APPLICANTS**

**ALL** applicants for consideration to all judging lists are at the discretion of the member Club's of the Breed Council.

Any application form listing shows from 1990 onwards. **ALL** records must be complete, otherwise, the show will not be included.

Any application with shows prior to 1990, records which are incomplete, a 25% reduction will be made on the entry detail.
